The purpose of our Privacy Policy is to advise what information is collected when you visit our site, how this information is used and stored and whether it is disclosed.

## **INFORMATION WE COLLECT**

We may collect and hold a range of different information about you; information can be categorised under 'Non-personally identifiable information' and 'Personally identifiable information' as described below.

### **Non-personally identifiable information**

Whenever you use our website, or any other website, the computer on which the web pages are stored (the Web server) will automatically record non-personally identifiable information. For us, this data includes:

- Your IP address
- Your general geographic location
- Your browser and device type
- The pages you visit on our website
- The time spent on those pages and the actions you take within our site.

### **Personally identifiable information**

You can visit our website without disclosing any personally identifiable information to us. However, if you purchase from us or choose to provide your personal information to us via a form, we will collect and store this information.

The types of personally identifiable information we collect and store can include:

- Your name
- Your child's name
- Your address and contact information
- Medical details for your child
- Records of your communication and interaction with us
- Previous purchases you have made.



If you do not provide certain requested personal information to us, we may not be able to provide you with the full and appropriate extent of our services.

We do not keep a record of the IP addresses from which users access our site except where you have specifically provided us with personal information, in which case we also record your IP address for security purposes. An example of this would be when proceeding to a checkout to finalise an order you may wish to make. After completing the form provided, your IP address will be stored along with a transaction number that allows us to track your order.

## **HOW WE COLLECT THIS INFORMATION**

### **Non-personally identifiable information**

### **Personally identifiable information**

We may collect your personal information in several ways, including when you:
